5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 11-01-2022 13:00 at the Office of State Assembly Secretariat, Lumbini Province, Butwal-Rupandehi, Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NRs. 225000.0, which shall be valid for 30 days beyond the validity period of the bid.
