State Assembly Secretariat, Lumbini Province, Butwal invites sealed bids or electronic bids from Nepalese eligible bidders for the Construction of Compound wall of Assembly Hall in Rapti Rural Municipality Deukhuri, Dang under National Competitive Bidding procedures. The estimated amount for the works is Rs. (in NRs) 3280697.49 (Exclusive of VAT and Contingencies)

3. Bidder submit their bid electronically may download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost Nrs 3000 of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Pre-bid meeting shall be held at State Assembly Secretariat, Lumbini Province, Butwal Rupandehi Nepal at 06-01-2022 14:00 hours.
5. Electronic bids must be submitted to the office State Assembly Secretariat, Lumbini Province, Butwal, Rupandehi, Lumbini Province, Nepal through PPMO website www.bolpatra.gov.np/egp on or before 17-01-2022 12:00. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 17-01-2022 13:00 at the office of State Assembly Secretariat, Lumbini Province, Butwal Rupandehi Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NRs. 102000.00, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. If any provision of bid document is inconsistent with Public Procurement Act (PPA), 2063 and Public Procurement Regulations (PPR), 2064, the provision of bid document shall be void to the extent of such inconsistency and the provision of PPA and PPR prevail.
